

**Premium Auxiliary Power System  
Frigette Truck Limited Warranty Policy**

Subject to the conditions hereinafter stated, there is a limited, non-transferable warranty on Frigette Truck Climate systems to the original owner and installed by an authorized Dealer or installer under normal use and service to be free of defects in factory workmanship and material for a period of 24 months or 4,000 hours, whichever comes first, from date of installation. Frigette's warranty is conditioned on and only so long as the original purchaser owns the truck upon which the system was installed; limited to the above mentioned 24 months or 4,000 hours whichever occurs first. Only units manufactured from January 2, 2008 and later qualify for this warranty; earlier production versions still remain with the existing 1 yr/4000 hours.

The first 12 months warranty shall cover the complete APU for parts and labor excluding consumable maintenance items like oil filter and air filters. The second year limited warranty coverage on the remaining balance of 4000 hours shall include PARTS ONLY, (no labor) for major component items that include the Kubota engine and internal parts thereof (excluding engine accessories), generator module, compressor, condenser, evaporator blower assembly, radiator, radiator fan, starter, control panel and aluminum power section enclosure. Engine accessories that are not warranted in the second year include water pumps, fuel pumps, wiring, filter assemblies, engine mounts, exhaust outlet parts, relays, safety switches, run solenoid, fuel lines, mufflers, refrigerant lines, coolant surge tank, water valve, water hoses, and power cords. \*(See chart below)

During the warranty period, Frigette will have the option of repair or replacement with new or remanufactured parts at an authorized Dealer for any parts that are found to be defective under normal use and service specified within the warranty period. Such repair or replacement shall be the buyers exclusive remedy and shall constitute complete fulfillment of all obligations and liabilities with respect to the Frigette APU. **Frigette does not pay for air freight charges on warranty parts.**

**Shipment Damage is the responsibility of the carrier.** No warranty credits or replacements will be considered for claims marked "Damaged in shipment". All such claims must be made direct to the carrier concerned.

**The warranty Registration Card furnished with this system must be completed and mailed within 10 days after installation.** This warranty is specifically designed for class 8 semi truck application and not intended for installation on marine, R.V. or other mobile applications. This warranty does not cover any product which has been in Frigette's sole judgment subjected to misuse, neglect, alteration, accident, improper installation, improper maintenance, or which has been repaired outside of an authorized service facility. Frigette or any of its authorized dealers or service affiliates shall have the right to require that the Buyer provide maintenance records to show that the APU has been properly maintained.

**This limited warranty does not include consequential damages** such as transportation cost, hotels, meals, towing, downtime, and Frigette shall not be responsible for any such damages. Frigette shall have no liability in contract or in tort (including negligence or strict liability) or otherwise, for any injury or damage caused to vehicles, contents, pets, product cargo or other property for any special, incidental, indirect or consequential damages whatsoever.

**NOTE: Frigette warranty does not cover failures of 120V household appliances, such as tv's, computers, microwaves, etc. In order to protect these devices, it is required that they be powered through a Frigette "power line conditioner" part #030-00163.** Frigette's total cumulative liability shall in no event exceed the purchase price of the APU or part on which such liability is based.

Frigette's warranty does NOT include the following consumable or maintenance items; such as engine oil, filters, lubricants, filter elements, belts, glow plugs, batteries, fuses, dryers or engine coolants.

Frigette does not make, and does not authorize any person to make for us, any warranty other than the foregoing warranty. Such other warranties, if any, as may be imposed or implied by law are limited in duration to the duration of this written warranty.

**The original owner must present a valid Warranty Registration Card or proof of purchase to any authorized Distributor or Dealer to receive warranty service.** The repair or replacement of the defective parts under this warranty will be made by such Distributor or Dealer without charge for parts and labor to the original owner during the first 12 months or 4,000 hours, whichever occurs first, from date of installation and for parts only on major components list below for 24 months or balance of 4,000 hours whichever occurs first.

Dealer must call or fax a request for an "RMA" number for authorization to repair and return defective parts. Without this approval, claims may be denied.
